4 Hour Evaluation = 22.00

6 Pack = 198.00 (\$33 per day)

12 Pack = 363.00 (\$30.25 per day)

### Boot Camp Rates

4 Hour Evaluation = 33.00

Full day = 50.00

6 Pack = 272.00 (\$45.33 per day)

12 Pack = 545.00 (\$45.41 per day)

### We do also have half day packages available.

Day Training Half day

6 Half days = 126.00 (\$21.00 per day)

12 Half days = 231.00 (\$19.25 per day)

Boot Camp Half days

6 Half Days = 182.00 (\$30.33 per day)

12 Half Days = 363.00 (\$30.25 per day)

This is a contract between Pup-A-Razzi and the pet owner whose signature appears below (hereafter called "Owner").

1. **Owner agrees to pay a deposit for one full day of Day Training or Boot Camp services in advance.** This deposit will be applied to cover either a "no show" or late cancellation. A no show is defined as a reservation that is not cancelled by 5:00pm the night before and then not attended. A late cancellation is any reservation that is cancelled after 5:00pm. Late Fees are as follows: \$10 if picked up after 6:00pm or \$15 if picked up after 7pm. Late fees **must be paid** when the dog is picked up.
2. By signing this Contract and leaving his/her pet with Pup-A-Razzi, Owner certifies to the accuracy of all information on page 1 and 2 of the contract.
3. Pup-A-Razzi shall exercise reasonable care for the pet(s) entrusted by the Owner to Pup-A-Razzi for training. It is expressly agreed by Owner and Pup-A-Razzi that Pup-A-Razzi's liability shall in no event EXCEED THE CURRENT VALUE OF A PET OF THE SAME SPECIES AND QUALITY (as determined by an expert in the breed).
4. Owner specifically represents to Pup-A-Razzi that the pet has not been exposed to rabies, parvo or distemper within a thirty-day period prior to training.
5. IF PET BECOMES ILL OR IF THE STATE OF THE ANIMAL'S HEALTH OTHERWISE REQUIRES PROFESSIONAL ATTENTION, PUP-A-RAZZI, AT IT'S SOLE DISCRETION, MAY ENGAGE THE SERVICES OF A VETERINARIAN OR ADMINISTER MEDICINE OR GIVE OTHER REQUISITE ATTENTION TO THE ANIMAL, AND THE EXPENSES THEREOF SHALL BE PAID BY THE OWNER.
6. Owner is solely responsible for any harm caused by the pet, while the pet is attending Day Training and/or Boot Camp.
7. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Pup-A-Razzi.
