This is a contract between Pup-A-Razzi and the pet owner whose signature appears below (hereafter called "Owner").

1. **Owner agrees to pay for the Evaluation at time of scheduling and that is nonrefundable.**
2. **Two or more (cumulative) "No Show's" will result in the loss of your spot on the schedule.** You may be charged for these "No Shows" A no show is defined as a reservation that is not cancelled between 5 PM the day before and 9 am the day of. Initial \_\_\_\_\_
3. **Dogs must be on the schedule for that day, to attend. We **do not** have "Drop In" available.**
4. **Your dog must arrive "on time" each day, or we may have to turn you away for that day. Drop off is between 7 AM and 9 AM for morning or full day and 1 PM for afternoon sessions.** Initial \_\_\_\_\_
5. **Late Fees are as follows: \$30 if picked up after 6:00pm or \$40 if picked up after 6:30pm. Late fees **must be paid** when the dog is picked up. If a dog is not picked up by 7:00 PM, the dog will be boarded by an employee with boarding fees of 60.00 for the night, the late fee will still apply. Late fees also apply to AM dogs. Late Fees for AM dogs: \$30 after 2:00pm, \$40 after 2:30pm.** Initial \_\_\_\_\_
6. By signing this Contract and leaving his/her pet with Pup-A-Razzi, Owner certifies to the accuracy of all information on page 1 and 2 of the contract.
7. Pup-A-Razzi shall exercise reasonable care for the pet(s) entrusted by the Owner to Pup-A-Razzi for training. It is expressly agreed by Owner and Pup-A-Razzi that Pup-A-Razzi's liability shall in no event EXCEED THE CURRENT VALUE OF A PET OF THE SAME SPECIES AND QUALITY (as determined by an expert in the breed).
8. Owner specifically represents to Pup-A-Razzi that the pet has not been exposed to rabies, parvo or distemper within a thirty-day period prior to training.
9. IF PET BECOMES ILL OR IF THE STATE OF THE ANIMAL'S HEALTH OTHERWISE REQUIRES PROFESSIONAL ATTENTION, PUP-A-RAZZI, AT IT'S SOLE DISCRETION, MAY ENGAGE THE SERVICES OF A VETERINARIAN OR ADMINISTER MEDICINE OR GIVE OTHER REQUISITE ATTENTION TO THE ANIMAL, AND THE EXPENSES THEREOF SHALL BE PAID BY THE OWNER.
10. Owner is solely responsible for any harm caused by the pet, while the pet is attending Day Training and/or Boot Camp.
11. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Pup-A-Razzi.
